
JUDGMENT

ON READING THE PLEADINGS AND HEARING THE EVIDENCE and the submissions from counsel for the parties,

1. THIS COURT ORDERS that the Defendant shall pay to the Plaintiff the sum of \$17,000.00 in damages, payable forthwith.
2. THIS COURT ORDERS that the Defendant shall pay to the Plaintiff the sum of \$1,000.00 in costs, payable by no later than June 29, 2012.
3. THIS COURT ORDERS that the Defendant shall forthwith consent to the release of \$9,000.00 plus any interest being held in trust by Brad Comeau, and shall execute any and all necessary documents to effect the release of said sum to the Plaintiff forthwith.
4. THIS COURT ORDERS that the Defendant shall forthwith direct his insurer to pay insurance proceeds in the amount of \$8,000.00 to the Plaintiff forthwith, and shall execute any and all necessary documents to effect the release of said sum to the Plaintiff forthwith.

5. PROVIDED THAT THE funds referred to at paragraphs 3 and 4 herein are duly paid and are received by the Plaintiff, such amounts shall reduce the amount set out at paragraph 1 by a corresponding value.
6. THE PARTIES HEREIN mutually release one another from any and all claims that they may have against each other, including claim, cost and interest.

POST JUDGEMENT INTEREST at a rate of 3.0% shall accrue in accordance with the Courts of Justice Act.
