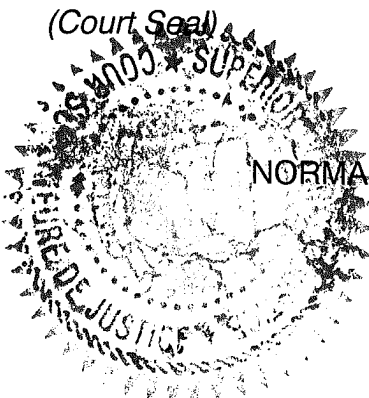

JUDGMENT

THIS ACTION was heard on April 28, 2010 without a jury at 330 University Avenue, Toronto, Ontario in the presence of counsel for the plaintiffs and the defendants, Norma Campbell and Nathaniel Campbell, appearing in person.

ON READING THE PLEADINGS AND HEARING THE EVIDENCE and the submissions of counsel for the parties,

1. THIS COURT ORDERS AND ADJUDGES that the Plaintiff recover from the Defendant Nathaniel Campbell the sum of \$18,736.66, with prejudgment interest at 2.5% from March 1, 2009 to April 28, 2010, for a total of \$19,279.51.
2. THIS COURT ORDERS AND ADJUDGES that the claim against the Defendant Norma Campbell is dismissed.

3. THIS COURT ORDERS AND ADJUDGES that the Plaintiff recover from the Defendant Nathaniel Campbell costs in the sum of \$11,694.60.
4. THIS COURT ORDERS that approval of the Judgment by the defendants as to form and content is not required.

THIS JUDGMENT BEARS INTEREST at the rate of 2% per year from its date.
